Regulates Marine Berths and Anchorages

In its weekly session held on March 22 2022, chaired by HH Sheikh Abdallah bin Salem bin Sultan Al Qasimi, Deputy Ruler of Sharjah and the Vice President of Sharjah Executive Council, and in the presence of HH Sheikh Sultan bin Ahmed bin Sultan Al Qasimi, Deputy Ruler of Sharjah and Sheikh Khaled bin Abdullah bin Sultan Al Qasimi, Chairman of the Sharjah Ports, Customs and Free Zones Authority, the Council issued resolution No. 11 for the year 2022 organizing the berths, marinas and anchorages of the Emirate of Sharjah.

Accordingly, the provisions of the resolution are applying on owners of maritime means of transports who are taking these marinas, berths and anchorages as loOding or berthing places.

The resolution stipulated the following:

1. Public docks within the seawaters of the Emirate of Sharjah are belonging to the Municipalities.
2. Anchorages and berths established in the Ports of the Emirate are belonging to Sharjah Ports, Customs and Free Zones Authority.
3. Investment Marinas which are allocated by the Government of Sharjah are belonging to Sharjah International Club for Marine Sports.

The resolution also regulated the specializations, management and supervision of the concerned Authorities in establishing marinas, berths and anchorages

Container Customs Centre Hosts Students

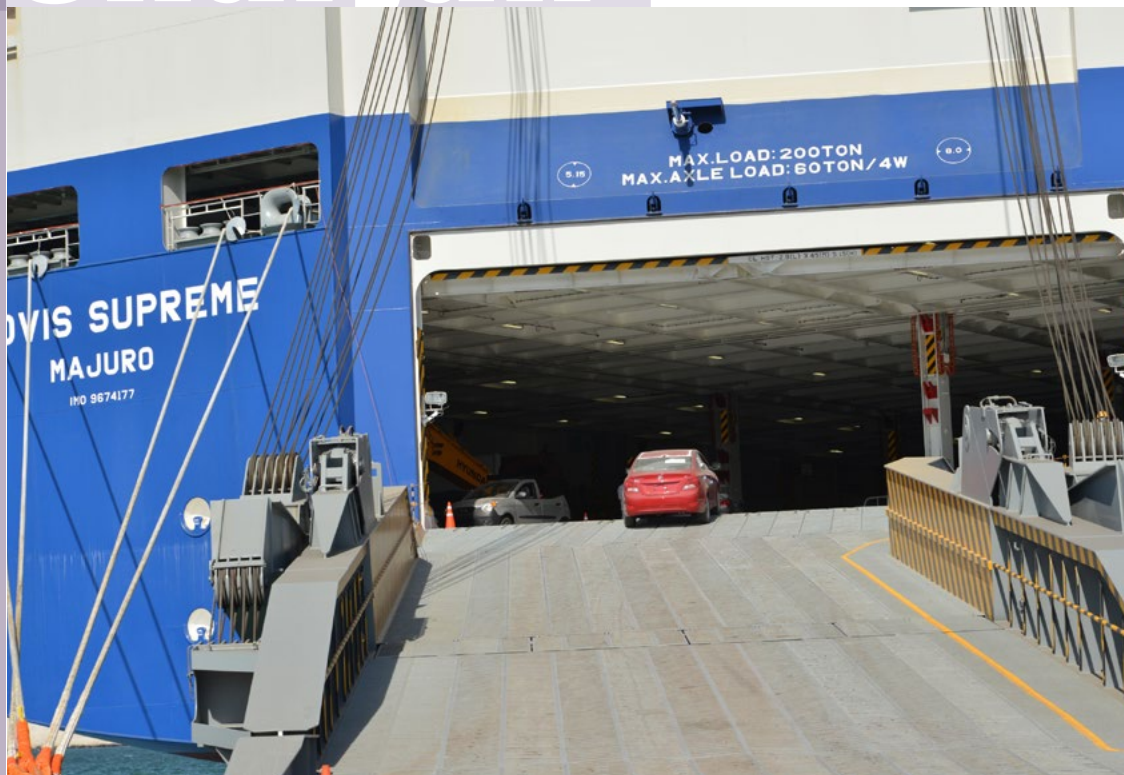

Along four days(28 Feb to 03 March 2022), the Container Customs Centre hosted students of Al Resalah International School of Science, Sharjah.

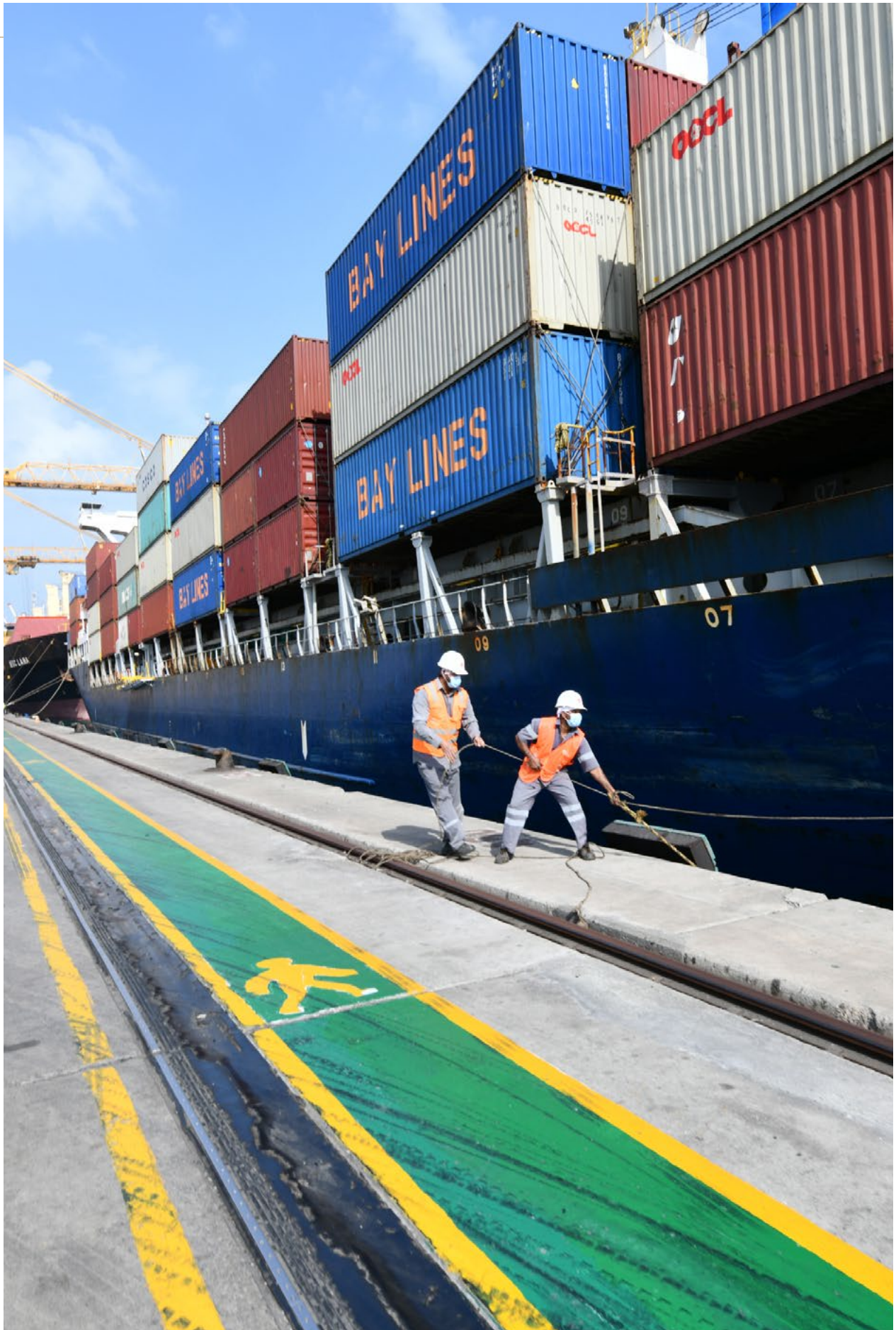




Sharjah Ports Record Higher Performance Figures

Sharjah Ports(Port Khalid, Port Hamriyah and Port Khorfakkan) sustained high figures of shipment of Vehicles and edible oils during the first five months of 2022 compared with the same period of 2021.

Shipments of edible oils witnessed an increment of 13.1% during the first five months (Jan to end of May) of 2022 and reached 1221,968 tons while it was 107,846 tons during the same period of 2021. Imported and exported vehicles through the ports of Sharjah have increased during the five month of 2022 to 31,928 Vehicles from 18,213 in the same period of 2021 recording an increment of 59.24%





The Sharjah Ports, Customs and Free Zones Authority maintains continually its plans to enhance employees' performance levels by organizing several training courses in which many customs inspectors and officer participate. The following training courses, to mention a few, were conducted during the second quarter of the year:

Skills of Arrest and Inspection

The Sharjah Ports, Customs and Free Zones Authority has conducted a training session on skills arrest and inspection.

The training session came within the course of the Sharjah Ports, Customs and Free Zones Authority to enhance the work of customs departments and centres by focusing on training as a vehicle to better performance.

The session has been conducted during the Period 01-03 March 2022 at the Container Customs Centre. Several Customs inspectors from various customs centres in the Emirate of Sharjah enrolled in this session.

The Legal Consultant Dr. Ahmed Mohammed Al Baker, supported by his impressive experience in legal customs-related affairs conducted several lectures during the session.

Security Threats at Terminals
