Foiled Attempts to Smuggle More than 136 KGs Narcotics Through Sharjah Airport During 2024

> The Sharjah Ports, Customs, and Free Zones Authority successfully foiled several separate attempts to smuggle over 136 kilograms of narcotic substances through Sharjah International Airport during 2024. This achievement reflects the authority's leading efforts in ensuring the security and safety of the community and highlights the efficiency of its advanced customs system.

 dditionally, the authority revealed the seizure of other narcotic substances at the airport, including more than 20,000 drug pills, as well as drug-laced stamps and containers. The confiscated items were referred to the relevant authorities for legal action. The authority emphasized that these drug seizures were the result of proactive monitoring, the constant vigilance of customs officers, their strong security awareness, and their meticulous inspection of travellers'

luggage and incoming parcels using the latest detection technologies and advanced customs systems.

The authority also praised the customs officers and inspection teams at the Passenger Customs Centre-Sharjah Airport for their awareness, high security alertness, and firm stance against smugglers and anyone attempting to bring prohibited substances into Sharjah's air, sea, and land customs ports. It reaffirmed its full commitment to deploying all available resources to enhance efforts in combating smuggling attempts of any kind, particularly narcotics. This commitment aligns with the national strategy to protect community's security and safety while also contributing to safeguarding and boosting the competitiveness and prosperity of the national economy.

# Always Ready to Handle Oversized Cargo Hamriyah Port Ships Project Equipment



Hamriyah Port, one of Sharjah's three seaports, is a versatile, multipurpose port capable of accommodating various types of vessels. Its development is closely linked to the growth of the Hamriyah Free Zone (HFZ). Additionally, the Inner Harbour of Hamriyah adds significant value by offering cost-effective port services to the free zone.

I he port serves not only HFZ investors but also traders and investors outside the free zone who benefit from its excellent connectivity to major highways, enabling efficient shipping of cargo. Hamriyah Port operates as a vital facility within the HFZ, playing an integral role in supporting its activities. Economically, HFZ investors rely on the port as their preferred terminal for importing raw materials and exporting finished products.

With a water depth of 14 meters alongside its berths, Hamriyah Port is fully equipped

to handle various types of vessels, including oil tankers, LPG carriers, steel products, grains, edible oils, general cargo, and project equipment.

Project shipments, renowned for their heavy weights and large sizes, require special safety and logistical arrangements for shipping on Heavy Lift Vessels, which are specifically designed for such tasks.

Recently, the MV BIGROLL BISCAY, a heavylift carrier, transported project cargo shipment from Hamriyah Port to Belgium. With a deadweight of 12,284.80 metric tons and a

deck size of 145 x 32 meters, it offers a vast area for heavy load cargo.

Hamriyah Port is always prepared for such operations, with ample space adjacent to the berths, making it an ideal location for receiving, preparing, and shipping equipment or breakbulk cargo.

## Another year of Success for Sharjah Ports: 2024

The year 2024 marked a successful milestone for all ports in the Emirate of Sharjah, including Port Khalid, Hamriyah Port, and Port Khorfakkan, as they achieved new records in port operations. These records reflect significant improvements in port performance and productivity, underscoring the commitment of the visionary leadership of the Government of Sharjah to the continued development of its ports, leading to substantial advancements.

 V otably, there was remarkable progress in container handling at Sharjah Container Terminals (Sharjah Container Terminal at Khalid Port and Khorfakkan Container Terminal at Khorfakkan Port), which reached 1,084,385 TEUs in 2024. This was nearly double the amount handled in 2023, which was 566,194 TEUs, representing a growth of 92%.

General cargo (non-oil cargo) shipped


through Sharjah Ports reached 4,134,747 tons in 2024, showing an increase of 24% from 3,886,119 tons in 2023.

Additionally, roro cargo movement saw a significant rise, with 118,116 vehicles handled in 2024, compared to 90,914 in 2023, reflecting a 30% increase.

The number of vessels calling at Sharjah Ports also grew from 8,264 in 2023 to 8,647 in 2024, marking a 5% increase.
